### **TERMS AND CONDITIONS OF LICENCE**

- 1) The Licensor has agreed to grant the Licensee the right to advertise, on panel (herein called the "Advertising Panel") located according to type of use (under "Selection of Panel Location") of the Licensor's building known as "BUGIS CUBE", Singapore (hereinafter called "the said Premises")
- 2) In consideration of the aforesaid Agreement, the Licensee shall pay in advance a licence fee according to type of use (under "Selection of Panel Location").
- 3) The Licensee agrees and undertakes to pay directly all charges, fees whatsoever levied by the relevant government authorities and any other government charges related in the said premises and to comply with such requirements as may be imposed on the Licensee or the Licensor by any legislation now or hereafter in force and any others, rules, regulations and notices thereunder. The Licensee undertakes at any time during the currency of this Agreement to remove any Advertisement which in the opinion of the Licensor is of a competitive nature to any of the occupants' business carried out in the said Premises.
- 4) The Advertisement installed by the Licensee shall remain the property of the Licensee and the Licensor shall not be responsible for any loss or damage to the Advertisement due to any cause whatsoever. The Licensee shall not be allowed to display or perform any items or activities that are offensive, illegal, immoral, dangerous or becomes an annoyance or nuisance to the public, and it must not be detrimental to the existing business of the said Premises.
- 5) The Licensee shall remove the Advertisement at the termination of this Agreement and undertakes to restore the Advertising Panel, to its original state and shall make good any damage caused by reason of the fixing or removal to the satisfaction of the Licensor, failing which the Licensor shall execute such restoration or repairs and the cost thereof shall be a debt due from the Licensee to the Licensor and be recoverable forthwith as such.
