4. A written one month notice is required for termination of the season parking. There shall be no refund of parking fee for the balance unused period.
5. To comply with the terms and conditions imposed by the Management Corporation governing the use season parking.
6. The Management Corporation reserves all right to refuse entry and revoke its consent without assigning reason for the use of season parking.
