## METHODS FOR PAYMENT OF MAINTENANCE FEE via INTERNET TRANSFER or BANK STANDING INSTRUCTION

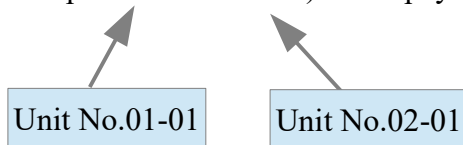
Dear Owners,

Also, you **must indicate your block and unit number as a reference number ;**  
(for example 01-01 or 02-01) in the payment transaction.



Please to remind that payment are to be made before the expiry of the grace period. Otherwise, the late payment interest shall still apply.

You should still expect the MCST sending you the invoices for maintenance fee in the manner prescribed by the resolutions passed by the general meeting.
